## **Rules for Selling**

1. Rules are for an annual event sponsored by the Villages Arts and Crafts Association and featuring fine art, quality craft and designer merchandise. The event is open to persons living in The Villages and non-residents who create their own work and have a Villager as a sponsor.

2. Each artist wishing to display and sell their items MUST sign a contract no later than two weeks <u>before</u> the event. Residents will be able to sign up for your own table or space. Non-residents will be assigned a table or space by the Contracts Chair.

3. All new artists must be juried before signing a contract. Returning artists must be juried if new items are to be sold.

4. No Agents, Dealers or Traders are eligible. Repaired jewelry or other objects refurbished are not considered and art or craft.

5. No artwork or crafts sold can have any trademarked items, or political content. Artwork deemed offensive or demeaning will be removed.

6. All artists must be present to participate. If unable to attend, you are required to withdraw from the event. Do not leave your table unattended at any time. Team Members are available for you to take a break.

Sign and date on page 2.

7. Be sure your prices include a commission (10% for Members, 15% for Non-Members, 20% for Non-Residents) to be paid to Arts and Crafts Association, plus any taxes. You are responsible for your own taxes.

8. Check in with the Event Registrar BEFORE YOU SET UP. You must pay your commission to the Commissions Chair at the same place at the end of the event.

9. You can supply your own table cover and may start setting up on Saturday at <u>7:30</u> a.m., not earlier. Each artist is responsible for their own table decoration and maintaining a professional atmosphere. No artist's display shall encroach on another artist's space or block the view of another table with signs, racks, or objects. Do not hang any items on the picnic table umbrella. No artist may display goods on any other space except the one assigned. Empty tables may not be taken over.

10. The event begins at <u>10:00</u> a.m. and ends at <u>2:00</u> p.m. Do not leave or begin packing up prior to the end time. Artists who are not present by thirty (30) minutes before the event start time will lose their tables.

12. After unloading your car, remove it from the parking places nearest Gazebo Park and park near the Vineyard Center so that customers will have room to park.

13. Animals are not allowed at OR within any event sponsored by Arts and Crafts.

14. Liability: The Arts and Crafts Association nor The Villages assume any responsibility for accident, damage, or loss.
